General Recommendations:

- -Good training of the forces of order maintenance on all security operations and coordination and exchange of information at the local, regional and international level .depending on the type of competition
- -The establishment of modern and sophisticated operating rooms for follow-up developments inside and outside the stadiums, consisting of police, local administration and judicial authorities.

The various media to raise awareness of the masses and explain the concepts and laws of sports modified and that the sport (winner and loser) and to target in the plan and in her speeches affect the minds

- -Follow the plan to evacuate the public in the event of disasters on the stadium and are printed and distributed to the public or be announced to them in one way or another, as happens in aircraft and other and the interests of the police to comply with the completion of work plans.
- -Focusing on the establishment of specialized centers in research, scientific, sports, educational and security studies to benefit from field work and conducting comparative studies at all international and local stadiums.

- -Work to allocate strips to the fans of each of the competing teams to avoid friction between them and prevent the occurrence of violence and riots.
- -The establishment of a security barrier to prevent public access to the ground and the invasion of the field in order to avoid disruption of the game or an attack on players and referees. The enactment of deterrent penalties for extremists of violence, violence in the stands, and preventing them from entering and watching the matches.
- -Spreading tolerance and renouncing religious and ethnic racism through exercise reduces the processes of extremism The sports clubs were urged to welcome the visiting teams.. To take care of the important and official personalities in terms of locating their places of entry and exit, and inspecting their places of residence and securing them.
- -Emphasis on preventing the sports public from entering the stadiums from taking the tools that can be used for extremism and violence inside the stadiums, such as fireworks, water bottles, solid materials and steel bars, with the need to conduct a careful inspection of the public at the entrance level of the stadium.
- -Conducting a comprehensive survey of stadiums and sports facilities.
